Why seek endorsement?



Endorsement provides:

- Official recognition that the initiative is part of a collective, global effort to meet the Ocean Decade vision.
 - Increased collaboration when part of a Decade Programme
- Opportunities for new participation and partnerships across disciplines, geographies and generations
- High visibility for the initiative
- Opportunities to access new sources of support

Decade Actions



There are 4 types of Endorsed Decade Actions:

- **Programmes**: Long-term, overarching initiatives that usually tackle multiple challenges; often global, can be regional
- Projects: Discrete or focused undertakings at regional, national, or sub-national scales; these can be 'nested' under one or more Programmes
- **Contributions**: Financial or in-kind resources
- Activities: Stand-alone initiatives, often enabling a Projects or Programme or contributing to a Challenge




Decade Activities can be submitted for endorsement at any time



Technical review by the DCU will take at least 6 weeks.













Invitation: Calls for Programmes and Projects



Announced every 6 months (March/October)

Call timeline	Programme focus	Projects
Call 01 October 2020–January 2021	Programmes and Contributions across all priorities and challenges	
Call 02 October 2021–January 2022	Programmes that address priority issues including marine pollution, multiple stressors on marine ecosystems or the ocean-climate nexus	
Call 03 March 2022–August 2022	Challenge 3—Sustainable Blue Food, Challenge 4—Sustainable Ocean Economy	Projects that have synergies with one of the 17 Programmes that have indicated that they are ready to solicit projects under the call
Call 04 (OPEN) October 2022–January 2023	Challenge 6—Coastal Resilience and Multi-Hazard Early Warning Systems, Challenge 8—Digital Representation of the Ocean	Projects that have synergies with one of the 25 Programmes that have indicated that they are ready to solicit projects under the call

- Reach out to Programme(s) (DCC-NEP can identify and make these connections)
- If needed, send your proposal to the DCC-NEP for review
- Submit a proposal through the online form




Proposal: Requesting endorsement for a project



Tips for a successful project proposal:

- Succinct written answers
- Well-articulated responses to the endorsement criteria showing how you already or will align with them through action
- Explain clearly how co-design processes are embedded in your proposed Action including which stakeholders and how the results will be shared/used
- Describe how your project aligns with a global programme
- Ensure all listed partners are made aware of the proposal
- Provide accurate information about project financing and describe plans for sourcing additional support

Proposal: Endorsement criteria (from guidance document)




- 2. Accelerate the generation or use of knowledge and understanding of the ocean, with a specific focus on knowledge that will contribute to SDGs.
- 3. Are co-designed or co-delivered by knowledge generators and users, and facilitate the uptake of knowledge for policy, decision making, management and/or innovation.
- 4. Ensure that all data and resulting knowledge are provided in an open access, shared, discoverable manner, and are deposited in recognized data repositories.
- 5. Strengthen existing or create new partnerships.
- 6. Contribute toward capacity development.
- 7. Overcome barriers to diversity and equity.
- 8. Collaborate with and engage local and indigenous knowledge holders.

Review: Requesting endorsement for a project

Review is expected to take 3-6 months:

- DCU technical review, for Projects applying through a Programme will include advice of relevant programme
- DCU may consult with Decade Coordination Offices and Decade Collaborative Centers to request advice that may fall within their purview

Once through review, DCU will recommend endorsement to the Executive Secretary of the IOC.



Project Endorsement:



After a decision for endorsement is made by the IOC Secretariat, project proponents will receive:

- An endorsement letter from the DCU including a charter for endorsed Decade Projects
- Information on joining relevant Community of Practice(s) through the Global Stakeholder Forum
- Use of the Ocean Decade logo to signify endorsement
